

Until these papers are legally executed, the children remain wards of the Society, and under its guardianship. After they are completed, send us a certified copy. Keep one yourself, the original will be filed in the records of the court.

These papers are carefully prepared by an Attorney, conforming to the late Legislation in regard to the Children's Code of Virginia. Any reputable attorney would charge from ten to twenty five dollars or more and with these papers, you do not need an attorney at all.

We do not make any special charge, but would appreciate any contribution you may make toward the expense of preparing these papers, having them printed, acknowledged, etc. Make check to the Children's Home Society of Virginia. As you doubtless are aware this Society is a pure charity depending entirely upon charitable voluntary contributions.

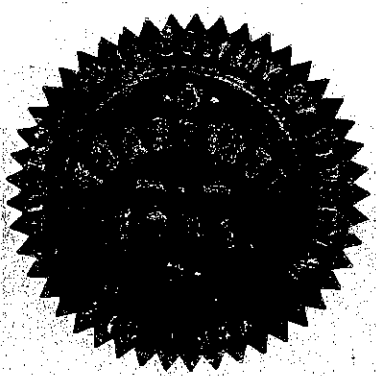

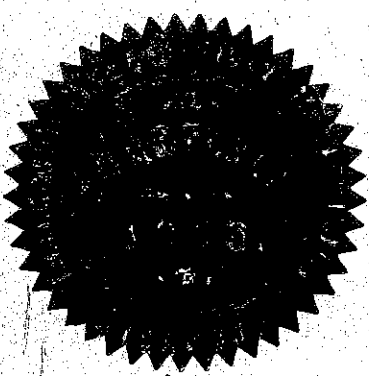


