Dear Sir:-

Mr. H. J. Latcher Stark has delivered to me for examination consents to the adoption of William Mills and Frank Mills, by H. J. Latcher Stark and his wife, Nita Hill Stark, executed by the Home Society of Virginia on January 29th, 1925.

As the names of the parents were incorrectly spelled in these papers, and in view of the fact that the other forms printed thereon are not consistent with the procedure of the Probate Courts in Texas with respect to the adoption of children, I have taken the liberty of preparing the enclosed consents to adoption in precise conformity with those already signed by the Childrens Home Society of Virginia, with the exception that I have correctly named the adopting parents, and have eliminated therefrom the other forms in connection with the Court proceedings.

As Mr. Stark is expecting to leave Orange for an absence of about thirty days during the latter part of next week, I shall be greatly obliged if you will have the President and Secretary of the Society to sign, acknowledge and seal the enclosed consents to adoption, and forward the same to me by return mail in the self addressed, stamped envelope enclosed herewith.

I shall appreciate very much if you will have the Clerk of the proper Court to probate and forward to me as soon as practicable certified copies of the Court proceedings pursuant to which these children were lawfully committed to the Childrens Home Society of Virginia; and if, under the laws of Virginia, no judicial action was required to lawfully commit these children to the Childrens Home Society of Virginia, I should like to have a copy of the instrument signed by the parents in connection with the commitment of these children. I shall, of course, be glad to remit promptly to the Clerk of the Court for the cost of the certified copies, and to you for such other instruments that you have in relation to the lawful commitment of the children.

I notice that in the case of Frank Mills the number is shown to be 2470, and in the case of William Mills the number is shown to be 3471. I assume that one or the other of the numbers is incorrect, as doubtless the numbers are either 2470 and 2471
