In the name of WILLIAM H. STARK, II or H. J. LUTCHER STARK, issued February 1943, 5 - \$1,000 certificates, Nos. M3377073E to M3377077E, incl., 5 - \$1,000 certificates issued in May 1945 in the name of WILLIAM H. STARK, II, Nos. M9806113E to M9806117E, inclusive,

receipt of the above numbered bonds being acknowledged by William H. Stark, II and Homer B. H. Stark, respectively, by signature hereto.

At the present time there remains a cash balance in the Nita Hill Stark Estate of \$16,398.59. Check No. 61 has been drawn in the amount of \$8,199.30 in favor of W. H. Stark, II; and Check No. 62 in favor of Homer Stark for \$3,199.29, leaving a balance of \$5,000 which will be held in the Estate until its closure, for contingencies.
